AUTHORIZING RESOLUTION

(Rising Development - Yonkers LLC Project - Extension of Sales/Use Tax Exemption Benefits)

A regular meeting of the City of Yonkers Industrial Development Agency was convened on Wednesday, December 16, 2015.

The following resolution was duly offered and seconded, to wit:

RESOLUTION AUTHORIZING THE CITY OF YONKERS INDUSTRIAL DEVELOPMENT AGENCY TO (i) EXTEND THE AGENT STATUS OF THE RISING DEVELOPMENT YONKERS LLC IN CONNECTION WITH A CERTAIN PROJECT UNDERTAKEN BY THE COMPANY AS AGENT OF THE AGENCY LOCATED AT 2 MILL STREET and 13, 27, 36 and 38 MAIN STREET, YONKERS, NEW YORK, AND (ii) EXECUTE AND DELIVER AN EXTENDED SALES TAX EXEMPTION LETTER AND EXTENDED NYS FORM ST-60 AND RELATED DOCUMENTS

WHEREAS, by Title 1 of Article 18-A of the General Municipal Law of the State of New York, as amended, and Chapter 83 of the Laws of 1982 of the State of New York, as amended (hereinafter collectively called the "Act"), CITY OF YONKERS INDUSTRIAL DEVELOPMENT AGENCY (hereinafter called the "Agency") was created with the authority and power to own, lease and sell property for the purpose of, among other things, acquiring, constructing and equipping civic, industrial, manufacturing and commercial facilities as authorized by the Act; and

WHEREAS, RISING DEVELOPMENT YONKERS LLC (the "Company") previously submitted an application (the "Application") to the Agency requesting the Agency's assistance with a certain project (the "Project") consisting of: (i) the redevelopment and adaptive reuse of five properties located at 2 Mill Street and 13, 27, 36 and 38 Main Street, Yonkers, New York (the "Land") to accommodate approximately 40,000 square feet of live/work space and approximately 17,500 square feet of cafes, restaurants and retail shopping to the commercial core of downtown Yonkers, New York (the "Improvements"), and (ii) the acquisition and installation in and around the Improvements of certain items of equipment and other tangible personal property (the "Equipment", and collectively with the Land, the Improvements, the "Facility"); and

WHEREAS, in connection with the Project and to effectuate the agent status of the Company, the Agency executed, among other things, a certain sales tax exemption package (the "Sales Tax Exemption Package") and an NYS Form ST-60, "IDA Appointment of Project Operator or Agent"; and

WHEREAS, the Agency by Resolution dated July 31, 2013 authorized the agent status of the Company for the period expiring December 31, 2015; and

WHEREAS, the Company has represented that the amount of purchases subject to the exemption and the Project size have not increased from the amounts described in the Application and has requested that the Agency extend the term of the Sales Tax Exemption Letter and NYS Form ST-60 to May 31, 2016, to provide additional time for the Company to complete the Project; and

WHEREAS, the Agency desires to adopt a resolution extending the agent status of the Company for the period December 31, 2015 to <u>May 31, 2016</u>, and authorizing the execution and delivery of a Sales Tax Exemption Letter and NYS Form ST-60 expiring <u>May 31, 2016</u>.

NOW, THEREFORE, BE IT RESOLVED BY THE MEMBERS OF THE CITY OF YONKERS INDUSTIAL DEVELOPMENT AGENCY AS FOLLOWS:

Section 1. The President, Chairman and/or Vice Chairman of the Agency are hereby authorized, on behalf of the Agency, to extend the agent status of the Company for the period December 31, 2015 to May 31, 2016, and execute and deliver a Sales Tax Exemption Letter and NYS Form ST-60 expiring May 31, 2016. The Agency is further authorized to file the NYS Form ST-60 expiring May 31, 2016, with New York State Tax Department's IDA Unit.

Section 2. The officers, employees and agents of the Agency are hereby authorized and directed for and in the name and on behalf of the Agency to do all acts and things required and to execute and deliver all such certificates, instruments and documents, to pay all such fees, charges and expenses and to do all such further acts and things as may be necessary or, in the opinion of the officer, employee or agent acting, desirable and proper to effect the purposes of the foregoing resolutions and to cause compliance by the Agency with all of the terms, covenants and provisions of the documents executed for and on behalf of the Agency.

<u>Section 3</u>. These Resolutions shall take effect immediately.
