(LOWE'S HOME CENTERS, LLC. – Extension of Sales/Use Tax Exemption Benefits)

A regular meeting of the City of Yonkers Industrial Development Agency was convened on Wednesday, November 30, 2016.

The following resolution was duly offered and seconded, to wit:

RESOLUTION AUTHORIZING THE CITY OF YONKERS INDUSTRIAL DEVELOPMENT AGENCY TO (i) EXTEND THE AGENT STATUS OF THE LOWE'S HOME CENTERS, LLC. IN CONNECTION WITH A CERTAIN PROJECT UNDERTAKEN BY THE COMPANY AS AGENT OF THE AGENCY LOCATED AT 470 NEPPERHAN AVENUE, YONKERS, NEW YORK, AND (ii) EXECUTE AND DELIVER AN EXTENDED SALES TAX EXEMPTION LETTER AND EXTENDED NYS FORM ST-60 AND RELATED DOCUMENTS

WHEREAS, by Title 1 of Article 18-A of the General Municipal Law of the State of New York, as amended, and Chapter 83 of the Laws of 1982 of the State of New York, as amended (hereinafter collectively called the "Act"), the CITY OF YONKERS INDUSTRIAL DEVELOPMENT AGENCY (hereinafter called "Agency") was created with the authority and power to own, lease and sell property for the purpose of, among other things, acquiring, constructing and equipping civic, industrial, manufacturing and commercial facilities as authorized by the Act; and

WHEREAS, the Agency previously appointed LOWE'S HOME CENTERS, LLC the true and lawful agent of the Agency to undertake a certain project (the "Project") consisting of: (i) the acquisition by the Agency of an interest, which interest is subordinate pursuant to Section 6.1(b) of the Agency Lease is, in certain improvements to be undertaken by the Company in certain land located at Block 4061, Lot 1 at the intersection of Ridge Hill Boulevard and Otis Drive Yonkers, New York (the "Land") and certain existing improvements located thereon, and improvements constructed by the Company consisting primarily of a non-prototypical 70K class C building. The main sales floor will have approximately 70,446 square feet of sales area with stacked offices and 15,000 square feet of a garden center; (ii) construction will include a brick/imprint/ painted walls, tube steel fencing, proposed LED lighting (the "Facility"); and

WHEREAS, the Company has agreed with the Agency, on behalf of the Agency and as the Agency's agent, to acquire, construct, install and equip the Facility in accordance with the plans and specifications presented to the Agency; and

WHEREAS, in connection with the Project and to effectuate the agent status of the Company, the Agency executed, among other things, a certain sales tax exemption package (the "Sales Tax Exemption Package") and an NYS Form ST-60, "IDA Appointment of Project Operator or Agent"; and

WHEREAS, the Agency by Resolution dated January 29, 2016 granted the agent status of the Company for the period between April 18, 2016 through December 31, 2016; and

WHEREAS, the Company has represented that the amount of purchases subject to the exemption and the Project size have not increased from the amounts described in the Application and has requested that the Agency extend the term of the Sales Tax Exemption Letter and NYS Form ST-60 to <u>December 31, 2017</u> to provide additional time for the Company to complete the Project; and

WHEREAS, the Agency desires to adopt a resolution extending the agent status of the Company for the period January 1, 2017 to <u>December 31, 2017</u> and authorizing the execution and delivery of a Sales Tax Exemption Letter and NYS Form ST-60 expiring <u>December 31, 2017</u>.

NOW, THEREFORE, BE IT RESOLVED BY THE MEMBERS OF THE CITY OF YONKERS INDUSTRIAL DEVELOPMENT AGENCY AS FOLLOWS:

Section 1. The President, Chairman and/or Vice Chairman of the Agency are hereby authorized, on behalf of the Agency, to extend the agent status of the Company for the period January 1, 2017 to <u>December 31, 2017</u>, and execute and deliver a Sales Tax Exemption Letter and NYS Form ST-60 expiring <u>December 31, 2017</u>. The Agency is further authorized to file the NYS Form ST-60 expiring <u>December 31, 2017</u> with New York State Tax Department's IDA Unit.

Section 2. The officers, employees and agents of the Agency are hereby authorized and directed for and in the name and on behalf of the Agency to do all acts and things required and to execute and deliver all such certificates, instruments and documents, to pay all such fees, charges and expenses and to do all such further acts and things as may be necessary or, in the opinion of the officer, employee or agent acting, desirable and proper to effect the purposes of the foregoing resolutions and to cause compliance by the Agency with all of the terms, covenants and provisions of the documents executed for and on behalf of the Agency.

<u>Section 3</u>. These Resolutions shall take effect immediately.
