Yonkers Partners in Education (YPIE) is a nonprofit organization serving 1,200 students/year. We partner with students to ensure they are ready for, enroll in, and complete college. We confront the challenges of a low-income, urban school district by providing families with equitable access to the critical tools and services necessary for college success.

YPIE is governed by a 25-member Board of Directors who contribute time, expertise and resources to help advance our mission and is supported by a staff of 21 employees. YPIE also has one of the largest volunteer programs in Westchester County, with more than 200 trained volunteers who make a multi-year commitment to students as mentors and college coaches.

In 2015, YPIE opened the city's only after school academic space - the YPIE College Zone - to focus on rigorous academics, interwoven with enrichment and other 21st century skill activities. This 5,200 square foot facility is located in downtown Yonkers.
