Our Company does Rigging for the Special Events and Entertainment industries. Both industries have been completely shut down due to COVID-19 as no public gatherings have been allowed.

We have been offered a few small gigs. The nature of our business requires our riggers to work together and in relatively close proximity. We have done our best to secure face shields to attach to their helmets as well as masks and institute other social distancing best practices. Each individual gig presents unique challenges and this grant money would help us adapt to those challenges and keep our employees safe. While we have not yet reached the \$10,000 limit, we expect that our costs for these specific jobs will be well in excess of \$10,000. We need to hire people to reconfigure our warehouse, erect dividers where appropriate, purchase additional protective equipment and accommodate the needs of each gig as it arises.

We broke down our expenses and took 29 employees off of the unemployment rolls and paid them to stay home and stay safe per State PAUSE orders. We have exhausted those funds. Our industry is still mostly shut down. We are utilizing our savings to continue to pay for our employees healthcare while they are furloughed. These funds would help ease the burden of the everchanging PPE needs when small gigs do arise.
