US+U/Warburton Galerie is an artist run arts organization. We host exhibitions that include artists from YOHO, Ludlow and the Bronx as well as Brooklyn, Queens & Manhattan and Tri-State area. We have an artist residency program which enables an artist to work onsite in a designated space for 3-6 months, ending in a solo exhibition. Artists in Residence teach two classes to local youth free of charge during their time with us. We have an credit bearing internship program which has hosted students from Westchester Community College/ and the College of Westchester. We have instructional art workshops/classes for both youth and adults. We recently completed an 8 session series funded by a Arts Westchester grant by doing the second half via zoom during the pandemic.
