

NOTICE OF PUBLIC HEARING

NOTICE IS HEREBY GIVEN that a public hearing pursuant to Article 18-A of the New York General Municipal Law will be held on Thursday, October 20, 2022, at 2:00 p.m., local time, by the City of Yonkers Industrial Development Agency (the "Agency") at the Agency's offices at 470 Nepperhan Avenue, Suite 200, Yonkers, New York 10701, in connection with the following matter:

WHEELER BLOCK YONKERS LLC, a New York limited liability company, for itself or on behalf of an entity to be formed has submitted an application (the "Application") to the Agency requesting the Agency's assistance with a certain project (the "Project") consisting of: (i) the acquisition or retention of the land commonly known as 15, 19 and 23 North Broadway (Section 2, Block 2003, Lots 22, 25 and 27) (the "Land"); (ii) the construction, renovation, improving, maintaining and equipping on the Land of the existing three, vacant, historic apartment buildings, including approximately 36 apartments (24 one-bedroom units and 12 alcove studio units, 5 units will be set aside as "HOME" rental units), accessibility improvements, a new residential lobby, and ground floor commercial space (the "Improvements"); and (iii) the acquisition and installation in and around the Land and Improvements of certain items of equipment and other tangible personal property (the "Equipment"); which together with the Land and Improvements are the "Facility".

The Agency will acquire (or retain) title to or a leasehold interest in the Facility as well as an interest in the Equipment and lease the Facility back to the Company. The Company will operate the Facility during the term of the lease. At the end of the lease term, the Company will purchase the Facility from the Agency, or if the Agency holds a leasehold interest, the leasehold interest will be terminated. The Agency contemplates that it will provide financial assistance (the "Financial Assistance") to the Company in the form of (i) a sales and use tax exemption for purchases and rentals related to the acquisition, construction and equipping of the Project, (ii) an exemption of New York State and local mortgage recording taxes as permitted by law, both consistent with the policies of the agency, and (iii) a partial real property tax abatement structure under a payment in lieu of taxation agreement.

A representative of the Agency will be at the above-stated time and place to present a copy of the Company's project Application and hear and accept written and oral comments from all persons with views in favor of or opposed to or otherwise relevant to the proposed Financial Assistance.

The Agency will provide access to the public hearing by broadcasting the public hearing in real time online at <https://yonkersida.com/live-stream/>.

The Agency encourages all interested parties to submit written comments to the Agency, which will be included within the public hearing record.
